When a CUA is mandatory, the following WA Public Authorities MUST buy from contracted CUA suppliers. However, buying rules vary from one CUA to the next, with some being mandatory state-wide while others are only mandatory for purchasing in the Perth region. Regional based offices can apply local purchasing discretion under the Buy Local policy.

Exclusions may apply in the following situations: where a public authority has an existing contract in place prior to the award of the CUA and when exemptions have been approved by the Department of Treasury and Finance (DTF).
